Fabricators:

Insert the appropriate District-dedicated address in the “To”(when District reviewed) or “CC”(when Division or Consultant reviewed) field of every shop drawing submittal. Copy the contractor and other recipients as directed by the Engineer. Obtain the address of the reviewer from the Engineer, and submit directly to that address. Avoid forwarding submittals through intermediate offices as resulting subject line revisions may trigger rejections by automated login filters.

The “Contact” email addresses are for your use in obtaining general information on District preferences concerning electronic submittal of shop plans. Shop drawing submittals should not be sent to these addresses.

Use the Division email addresses only if directed by the Engineer.

(*Excluding the Materials/Tests Division address. This address is solely for the purpose of receiving copies of approved shop drawing sets from TxDOT reviewing offices.)

Key to specific addresses for Districts with multiple addresses:

Austin District: Obtain specific addresses in the General Notes of the Contract Plans.

Houston District: Obtain specific addresses in the General Notes of the Contract Plans.
