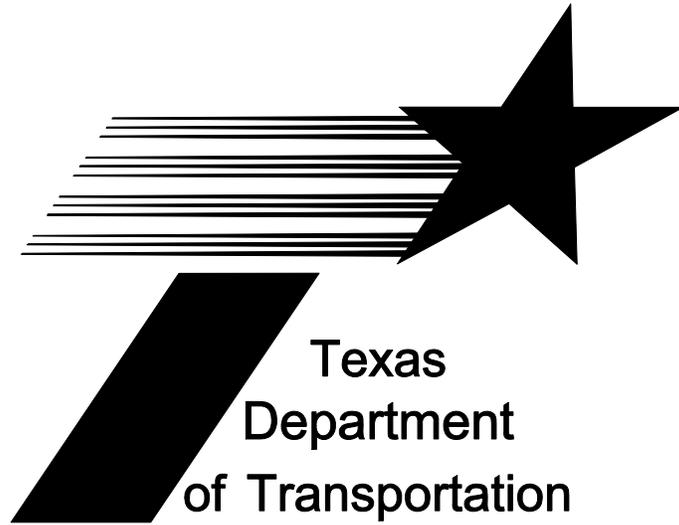



On October 3, 2008, the Eastern Federal Lands Highway Division (EFLHD) distributed the FY 2009-2012 Transportation Improvement Program (TIP) for projects administered for the Federal Lands Highway Programs. Coordination with the State Transportation Improvement Program (STIP) is required as part of the amendment process.
