*This minute order appoints members to the Border Trade Advisory Committee. The purpose of the committee, created in 2001 by the 77th Legislature, is to define and develop a strategy and make recommendations to the commission and the governor, to address the highest priority border trade transportation challenges.*

Consider the appointment of members to the Bicycle Advisory Committee [\(MO\)](#) [\(Presentation\)](#)  
*The Bicycle Advisory Committee advises the commission on bicycle issues and matters of mutual concern between the department and the bicycling community. By involving representatives of the public, including bicyclists and other interested parties, the department helps ensure effective communication with the bicycle community, and that the bicyclist's perspective will be considered in the development of departmental policies affecting bicycle use, including the design, construction, and maintenance of highways.*

**Hockley County** - City of Levelland - Consider final approval of a request from the City of Levelland for a State Infrastructure Bank loan in the amount of up to \$890,000 to pay the costs of utility relocation necessary for a state highway improvement project on US 385 ([MO](#))  
*The SIB loan will be secured by a pledge of water and sewer system revenues. The loan will be used to pay the costs of utility relocation necessary for a state highway improvement project on US 385 from FM 300 to 1.86 miles south of FM 300.*
- 115051**      9.      **Financial Assistance for Projects**  
**Bexar County** - Alamo Regional Mobility Authority - Consider granting preliminary approval of a request from the Alamo Regional Mobility Authority to receive a grant of up to \$17,000,000 to be used to pay for project development of the Loop 1604 Managed Lanes Project, which includes the addition of two tolled managed lanes in each direction along Loop 1604 from SH 16 to I-35 ([MO](#))  
*The Loop 1604 Managed Lanes Project consists of tolled and non-tolled improvements, including the addition of two tolled managed lanes in each direction along Loop 1604 from SH 16 to I-35, and the addition of eight direct connectors at the Loop 1604 and Interstate Highway 10 interchange. Additional improvements to Loop 1604 are planned as part of the project and include: (1) mill, overlay, and re-striping of the existing mainlanes; and (2) improvements to the non-tolled portions of the roadway, including frontage roads, ramps, intersections, and bicycle and pedestrian facilities.*
- 115052**      10.      **Audit and Compliance**  
Consider the approval of the Internal Audit Work Plan and the Compliance Work Plan for Fiscal Year 2018 and determine whether adequate resources have been dedicated to the internal audit and the compliance programs ([MO](#)) ([Presentation](#))  
*State law requires the internal auditor to create an annual audit plan that is prepared using risk assessment techniques and that identifies the individual audits to be conducted during the year. The audit plan must be approved by the commission. In addition, the commission must review the resources dedicated to the internal audit program and determine if adequate resources exist to ensure that risks identified in the annual risk assessment are covered in a reasonable timeframe. The Compliance Division has developed a work plan of external audits for fiscal year 2018. This compliance work plan was developed to implement Transportation Code, Chapter 201, Subchapter F-1, and is designed with engagements and activities focused on preventing and detecting serious breaches of department policy, fraud, waste, and abuse of office.*
11.      **Contracts**

*These proposed minute orders contain information concerning the receipt of bids for highway improvement contracts. - 115055** **Various Counties** - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) ([MO](#))  
*Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.*

*The commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.*
- 115057** (1) **Bexar County** - I-10, southeast corner at Fresno Drive in San Antonio - Consider the sale of right of way to the successful bidder ([MO](#))  
*The district has determined that the land is no longer needed for highway purposes. The local governmental entities and abutting landowners declined interest in purchasing the land, and it was advertised for sale by sealed bid. There were two bids, and the land may be sold to the high bidder.*
- 115058** (2) **Denton County** - FM 407, old alignment at Hilltop Road in Bartonville - Consider the sale of right of way to the abutting landowner ([MO](#))  
*The district has determined that the land is no longer needed for a state highway purpose. The abutting landowner has requested to purchase the land, and it may be sold to the abutting landowner.*
- 115059** (3) **El Paso County** - SL 375, northwest corner at I-10 in El Paso - Consider the sale of right of way to the abutting landowner ([MO](#))  
*The district has determined that the land is no longer needed for a state highway purpose. The abutting landowner has requested to purchase the land, and it may be sold to the abutting landowner.*
- 115060** (4) **Harris County** - I-10, northeast corner at Barker Cypress Road in Houston - Consider the sale of right of way to an abutting landowner ([MO](#))  
*The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the property. Another abutting owner has declined interest, and the property may be sold to the requester.*

*The district has determined that the land is no longer needed for a state highway purpose. The abutting landowner has requested to purchase the land, and it may be sold to the abutting landowner.*
- 115062** (6) **Sutton County** - FM 864 at I-10 east of Sonora - Consider the sale of right of way to the abutting landowner ([MO](#))  
*The district has determined that the land is no longer needed for a state highway purpose. The state owns part of the land in fee and part in easement. The abutting landowner, who is also the underlying fee owner of the easement, has requested to purchase the land, and it may be sold to the requester.*
- 115063** (7) **Travis County** - SL 275, S. Congress Avenue at W. Slaughter Lane in Austin - Consider the sale of a drainage easement ([MO](#))  
*The district has determined that the easement is no longer needed for highway drainage purposes and may be sold to the fee owner of the property.*

**Compliance Division report**

*State law requires the commission to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*

d. **Highway Designation**

- 115064** **Hidalgo County** - Consider extending the designation of FM 676 near the cities of Edinburg and McAllen ([MO](#))  
*This minute order extends the designation of FM 676 from 0.3 mile east of N. Taylor Road along Auburn Avenue to FM 2220 (Ware Road), a distance of approximately 1.0 mile.*

e. **Designation of Access Control**

- 115065** (1) **Coryell County** - US 190, east of FM 3046 in Copperas Cove - Consider the redesignation of one location on the eastbound frontage road at which access will be permitted to the abutting property ([MO](#))  
*The redesignation of one existing 126.48-foot break in the control-of-access line with one proposed 120.41-foot break in the control-of-access line will allow the abutting landowner to open one proposed driveway location for access to and from the eastbound frontage road. The district has determined that access may be permitted at the designated location.*
- 115066** (2) **Guadalupe County** - I-10, approximately 300 feet west of SH 80 - Consider the designation of two locations on the highway at which access will be permitted to the abutting property ([MO](#))  
*The designation of one 50.58-foot break and one 47.07-foot break in the control-of-access line will allow the abutting landowner to open two proposed driveway locations for access to the eastbound frontage road. The district has determined that access may be permitted at the designated locations.*

*The designation of one 20-foot break in the control-of-access line will allow the abutting landowner to open one proposed driveway location for access to the southbound frontage road. The district has determined that access may be permitted at the designated location.*
- 115069** (5) **McLennan County** - I-35, south of New Road - Consider the designation of one location on the frontage road at which access will be permitted to the abutting property ([MO](#))  
*The designation of one 80-foot break in the control-of-access line will allow the abutting landowner to open one proposed driveway location for access, permitting access to and from the southbound frontage road. The district has determined that access may be permitted at the designated location.*
- 115070** (6) **Reeves County** - I-20, approximately 200 feet west of US 285 - Consider the designation of one location on the highway at which access will be permitted to the abutting property ([MO](#))  
*The designation of one 25-foot break in the control-of-access line will allow the abutting landowner to open one proposed driveway location for access to the westbound frontage road. The district has determined that access may be permitted at the designated location.*

f. **Transportation Planning**

- 115071** **Various Counties** - Consider the certification of eligible counties for the 2018 Economically Disadvantaged Counties Program and establish local match adjustments for each county and certain cities ([MO](#))  
*This minute order certifies the counties to participate in the Economically Disadvantaged Counties Program for Fiscal Year 2018 and sets forth the local match adjustment for each county and certain cities participating in the program. State law requires the commission to annually certify economically disadvantaged counties as soon as possible after the comptroller reports on the relevant economic indicators.*

g. **Speed Zones**

- 115072** **Various Counties** - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state ([MO](#))  
*This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*
