Accredited laboratories undergo rigorous on-site assessments by the central lab. During these assessments, each test method that a lab is seeking accreditation in will be demonstrated in its entirety by the laboratory's technical staff, and the testing apparatus associated with each test. The assessment may also include a thorough review of the laboratory's quality management system, including records of technician certification and proficiency requirements as well as equipment calibration records. Accreditation is an ongoing process and may be conducted on a 3-year cycle if warranted by the Texas DOT and project specifics.
