FACT SHEET

The TxDOT El Paso District is developing a Corridor Plan for a 15-mile section of Doniphan Drive between the Texas/New Mexico state line and Racetrack Drive in El Paso. Doniphan Drive is State Highway 20 from the Texas/New Mexico state line to Mesa Street in El Paso, and a City of El Paso roadway from Mesa Street to Racetrack Drive.

Primary Objective

The Corridor Plan will document the community’s vision for Doniphan Drive as it relates to future transportation and development along the corridor through 2040. One of the results of this process will be the identification of a set of improvements for short-, medium-, and long-term implementation. The development of the Plan will be accomplished through a process of data collection, analysis of current and future transportation needs and agency/public outreach to identify potential projects.

Get Involved


