



**Notice of Public Meeting**  
**County Road 59 from County Road 48 to Kirby Drive**  
**CSJ: 0912-31-305**

The Brazoria County Engineering Department, in conjunction with the Texas Department of Transportation (TxDOT), Houston District, will hold a Public Meeting regarding the proposed 1.1 mile long roadway widening of County Road (CR) 59 from County Road 48 to Kirby Drive in Brazoria County, Texas. The meeting will be held Tuesday, December 11, 2018 at Shepherd of the Heart United Methodist Church located at 12005 County Road 59, Pearland, TX 77584. The meeting will be held in an open house format from 5:30 p.m. to 7:30 p.m. No formal presentation will be made.

The purpose of the Public Meeting is to present the proposed project alternatives to the public and receive comments. The proposed County Road 59 project would widen the existing two 10-foot-wide lanes to four 11-foot-wide lanes divided by a 16-foot-wide raised grassy median. Drainage features would include curb-and-gutter and a redesigned open ditch drainage system. The proposed improvements would require approximately 9.0 acres of additional right-of-way and may require displacements.

Maps showing the proposed project's location and design alternatives will be available for review at the Public Meeting. This information will also be available by appointment for review Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m., excluding state holidays, at the TxDOT Houston District Office, located at 7600 Washington Avenue, Houston, Texas 77007.
