The Texas Department of Transportation (TxDOT), is proposing a new 4-lane divided highway facility along proposed new location, from FM 755 (2.5 Miles NE of US 83) to US 83 (1miles West of Loma Blanca Rd.). The total distance of the project is approximately 17 miles.

The purposes of these meetings are to allow the public the opportunity to view project related information and provide comments on the proposed SL 195 highway. The presentation will be the same at both meetings.

The proposed project will be constructed in three phases as traffic volumes increase and funding becomes available. This project involves constructing a four-lane divided rural highway with a grass median within a proposed right of way (ROW) width that varies between 300-450 feet.

Location maps, geometric design, and other information concerning this project will be presented at the meeting and are available for public viewing from Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m.at the TxDOT Pharr District Office located at 600 W. I- 2, Pharr, Texas 78577.

All interested citizens are invited to attend this meeting to provide input regarding the proposed project. Verbal and/or written comments may be presented at the public meeting. Written comments may be submitted up to 15 days after the public meetings, for the February 16, 2017 until March 3, 2017 and for the February 21,2017 until March 8, 2017 to TxDOT,, Attn: Pharr District Engineer, 600 W. The proposed project would require approximately 700 acres of additional roadway ROW. It is anticipated that the proposed project would require one business and eleven residential relocations. Relocation assistance is available for those displaced through TxDOT's Relocation Assistance Program. The relocation process would be conducted according to the Title II and Title III of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970. The public meetings will be conducted in English, with Spanish translation services also available.
