



NOTICE OF PUBLIC MEETING  
US 67/ US 87 Relief Route Study  
Tom Green County, Texas

The Texas Department of Transportation (TxDOT) will conduct a Public Meeting for the purpose of providing information to and gathering input from the public on the US 67/ US 87 Relief Route Study (Study) in San Angelo, Texas. As part of the Study, environmental data, public input, and recommendations will be utilized to improve safety and mobility in the vicinity of the City of San Angelo, Tom Green County, Texas. The study limits are from US 67/277 northeast of San Angelo to US 87 north of San Angelo in Tom Green County, Texas (study area). The goal of the study is to identify a safe alternative to existing US 277. The study will consider alternatives to enhance mobility and ease future traffic congestion by connecting US 277 to US 87 north of San Angelo.


The Public Meeting will be held on **Tuesday, March 24, 2020 at the Concho Valley Transit District (CVTD) Multi-Modal Annex Building, located at 510 N. Chadbourne St., San Angelo, TX 76903** from 5 - 7 p.m. The Public Meeting will be an Open House format with a formal presentation starting at **5:30 p.m.** The purpose of the meeting is to provide preliminary concepts and to receive public comment. Representatives from TxDOT and project consultants will be available to answer questions about the proposed project.

Maps of preliminary concepts will be available for viewing at the public meeting. This information will also be on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the TxDOT San Angelo District Office located at 4502 Knickerbocker Road, San Angelo, TX 76904. Project information also will be available online at [www.txdot.gov](http://www.txdot.gov) under "Upcoming Public Hearings/Meetings".

All interested persons are invited to attend this Public Meeting. Written comments from the public are requested and will be accepted for a period of 15 calendar days following the meeting.
