This document represents Addendum #4 to the Request for Proposals (RFP) for the I-635 LBJ East Project. Initially capitalized terms not otherwise defined herein shall have the meanings set forth in the RFP.

The RFP is hereby clarified and revised as follows:

1. Section 5.3.3(b) of the ITP is amended and restated as follows:

“Proposer has provided a Design-Build Price Breakdown (excluding the Skillman/Audelia Interchange Price) using Form P-2.1 that complies with the requirements of Exhibit C-2, Section 3.1.1.”

2. The second bullet point in Section 3.1.1 of Exhibit C-2 to the ITP is amended and restated as follows:

“A breakdown of the Design-Build Price (excluding the Skillman/Audelia Interchange Price) using Form P-2.1.”

3. All references to the title of Form P-2.1 in the ITP are revised to read as, “DB Price Breakdown (excluding the Skillman/Audelia Interchange Price)”.
4. Form P-1 is hereby amended and restated as set forth in Attachment 1-1 hereto.
5. Form P-2.1 is hereby amended and restated as set forth in Attachment 1-2 hereto.
6. Form P-2.2 is hereby amended and restated as set forth in Attachment 1-3 hereto.
