4. Aviation

Various Counties - Award federal and state grant funding for airport improvement projects at various locations ([MO](#))

Federal law authorizes the award of federal funding to preserve and improve the state's general aviation system. State law authorizes the award of state funding for capital improvement projects. The airports listed in Exhibit A are eligible for award of these grant funds and the department seeks approval of the awards.

113705 5. **Texas Mobility Fund**
Various Counties - Lone Star Rail District - Consider granting approval of a request from Lone Star Rail District in the amount of \$2 million for environmental and development studies relating to the provision of passenger rail services with funding from the proceeds of Texas Mobility Fund general obligation bonds issued under Transportation Code, Chapter 201, Subchapter M ([MO](#))
This minute order will provide funds for an award to the Lone Star Rail District for environmental work and development studies for a project to relocate existing rail freight to a new location in order to provide passenger rail service for communities from Georgetown to San Antonio on existing freight rail lines in the I-35 corridor.

113706 6. **Transportation Planning**
Starr County - Designate State Loop 195 along a new location near Rio Grande City ([MO](#))
This minute order designates State Loop 195 along a new location from the intersection of Loma Blanca Road and US 83 to FM 755, approximately 2.5 miles northeast of Rio Grande City, a distance of approximately 17.4 miles.

7. **Promulgation of Administrative Rules** Under Title 43, Texas Administrative Code, and the Administrative Procedure Act, Government Code, Chapter 2001:

113707 a. **Final Adoption**
 (1) **Chapter 9 - Contract and Grant Management ([MO](#))**
 Amendments to §§9.31 - 9.34, Repeal of §§9.36-9.40, and New §§9.36-9.42 (Contracting for Architectural, Engineering, and Surveying Services)
These amendments are necessary to update and streamline agency rules describing agency operations and for clarity and logical presentation. The new section provides for a new contracting process allowing the executive director to execute an engineering, architecture, or surveying contract when certain circumstances are present.

113708 b. **Proposed Adoption**
 (1) **Chapter 28 - Maintenance ([MO](#))**
 New §§28.100-28.107 (Hidalgo County Regional Mobility Authority)
These new sections provide the authority for the Hidalgo County Regional Mobility Authority (authority) to issue permits for the operation of oversize and overweight vehicles on specific roads within Hidalgo County. The sections also establish the guidelines for the agreement between the authority and the department and the requirements the authority must follow to issue the permits.

8. **Office of Compliance and Ethics**
Office of Compliance and Ethics Report
State law requires the commission to establish a compliance program, which must include a compliance office to oversee the program. The compliance office is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The compliance office is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.

- 113709 9. **Design-Build Agreements**
Various Counties - Authorize the department to issue a request for proposals for the design and construction of the Energy Sector Roadway Repair Project, comprised of improvements to identified roadways in the Corpus Christi, Yoakum, Laredo, and San Antonio Districts of the department, and approve a stipulated amount as payment for the work product of unsuccessful proposers (MO)
On July 25, 2013 in Minute Order 113648, the commission authorized the department to issue a request for qualifications for the project. This minute order continues the procurement process by authorizing the issuance of a request for proposals for the project, and approves a stipulated amount for the payment of work product of responsive, unsuccessful proposers.
- 113710 10. **Toll Roads**
Dallas and Tarrant Counties - Designate the I-30 Managed Lanes Project from west of North Fielder Road in Tarrant County to Sylvan Avenue in Dallas County as a toll project on the state highway system (MO)
The Texas Department of Transportation received final environmental clearance from the Federal Highway Administration on December 15, 2006. This minute order designates I-30 Managed Lanes Project from west of North Fielder Road in Tarrant County to Sylvan Avenue in Dallas County as a toll project on the state highway system.
- 113711 11. **Traffic Operations**
Travis County - Authorize temporary one-way or reversible operations on FM 973 (MO)
Authorize temporary one-way or reversible operations on FM 973 between SH 71 and FM 812 for the Circuit of The Americas (COTA) events for the next four (4) years.
- 113712 12. **Contracts**
Award or reject contracts for maintenance, highway and building construction
These proposed minute orders contain information concerning the receipt of bids for highway improvement contracts. The department may reschedule receipt of bids for those projects where the commission rejects all bids. Those bids accepted by the commission will result in conditional contract awards to the low bidders. Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy federal DBE subcontracting requirements, or other requirements as outlined in the project bid proposal.

- 113714 13. **Eminent Domain Proceedings**
Various Counties - Authorize the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached list) (MO)
Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.

a. **Donations to the Department**

Various Districts - Consider the acceptance of donations made to the department to include: (a) donations in any form, including realty, personalty, money, materials, or services, which are made to the department for the purpose of carrying out its functions and duties; and (b) donations from landowners, with land adjacent to a highway that is part of the state highway system, to construct an improvement on the highway right-of-way that is directly related to improving access to or from the owner's land (See attached itemized list) [\(MO\)](#)

The donations will ensure the safety of the traveling public.

b. **Right of Way Dispositions and Donations**

(1) **Brazoria County** - SH 288 from Harris County line to SH 332 in Lake Jackson - Consider the acceptance of a donation of land for a highway improvement project [\(MO\)](#)[\(MO\)](#)

113717

The property being donated to the department is necessary for construction of a right turn lane on SH 288. The property being donated is in lieu of payment for the acquisition and is valued at more than \$500.

113718

(2) **Fort Bend County** - FM 1463 from 0.009 miles north of Fry Road to Langham Road - Consider the acceptance of a donation of land for a highway improvement project [\(MO\)](#)

The property being donated to the department is necessary for the construction of a right turn land on FM 1463. The property being donated is in lieu of payment for the acquisition and is valued at more than \$500.

(3) **Liberty County** - FM 1413, old alignment at SH 146 - Consider the removal from the system, designation on a new location, release of a surplus right of way easement and waiver of the service fee [\(MO\)](#)

Realignment of FM 1413 has been completed, and the district recommends removal of the old alignment and designation of the new segment on system. The district also recommends the release of a surplus easement on the old alignment to honor a reversionary clause and that the service fee be waived.

(4) **Potter County** - SL 335 south of I-40 in Amarillo - Consider the exchange of drainage easements and acceptance of a donation to the state [\(MO\)](#)

The fee owner of the property has requested the department to realign an existing drainage easement to facilitate development of the property and has granted a new easement to the state. The district has determined that a portion of the existing drainage easement is no longer needed for highway purposes, and it may be released to the owner of the property. The owner has agreed to donate the difference in value to the state.

c. **Release of Access**

113721

Tarrant County - I-35W, southbound frontage road, north of Basswood Blvd in Fort Worth - Consider the designation of a location on the highway at which access will be permitted to the abutting property [\(MO\)](#)

The designation of a 40-foot break in the control-of-access line will allow the abutting landowner to open a proposed driveway location for access to and from the southbound frontage road. The district has determined that access may be permitted at the designated location.

14. **Routine Minute Orders (continued)**

- 113722 d. **Redesignation of Access Control**
Travis County - Authorize the redesignation of access control along US 290, approximately 600 feet west of the SH 130 intersection, for the properties owned by BFI Waste Systems of North America, LLC, to move the access point from its original location to a new location (MO)
US 290 is a controlled access facility and BFI Waste Systems of North America, LLC is requesting that its properties' existing point of access to US 290 be relocated from the existing location. The original access point will be removed and access will be denied at that location.
- 113723 e. **Transportation Planning**
Various Counties - Certify eligible counties for the 2014 Economically Disadvantaged Counties Program and establish local match adjustments for each county and certain cities (MO)
This minute order certifies the counties to participate in the Economically Disadvantaged Counties Program for Fiscal Year 2014 and sets forth the local match adjustment for each county and certain cities participating in the program. State law requires the commission to annually certify economically disadvantaged counties as soon as possible after the comptroller reports on the relevant economic indicators.
- 113724 f. **Reports**
Travis and Williamson Counties - Accept the Report of Actual Traffic and Revenue for the Central Texas Turnpike System (CTTS) (MO)
Report of actual traffic and revenue for the CTTS as of August 31, 2013, as required by the CTTS Indenture of Trust.
- 113725 g. **Speed Zones**
Various Counties - Establish or alter regulatory and construction speed zones on various sections of highways in the state (MO)
This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.
