# Annual Report to the Legislature on Certain Matters



Submitted in Compliance with Section 201.616 of the Texas Transportation Code

# INTRODUCTION

Section 201.616 of the Texas Transportation Code requires the Texas Department of Transportation to submit an annual report on certain matters. The text of that requirement is:

## § 201.616. ANNUAL REPORT TO LEGISLATURE ON CERTAIN MATTERS.

- (a) Not later than December 1 of each year, the department shall submit a report to the legislature that details:
  - (1) the expenditures made by the department in the preceding state fiscal year in connection with:
    - (A) the unified transportation program of the department;
    - (B) turnpike projects and toll roads of the department;
    - (C) the Trans-Texas Corridor;
    - (D) rail facilities described in Chapter 91; and
    - (E) non-highway facilities on the Trans-Texas Corridor if those expenditures are subject to Section 227.062(c);
  - (2) the amount of bonds or other public securities issued for transportation projects; and
  - (3) the direction of money by the department to a regional mobility authority in this state.
- (b) The report must break down information under Subsection (a)(1)(A) by program category and department district. The report must break down information under Subsections (a)(1)(B), (C), (D), and (E) and Subsection (a)(3) by department district. The report must break down information under Subsection (a)(2) by department district and type of project.
- (c) The report may be submitted in an electronic format.

# **FISCAL YEAR 2004 EXPENDITURES**

#### **Unified Transportation Program**

The attached schedules provide the Unified Transportation Program expenditures by program category and department district.

#### Turnpike Projects and Toll Roads

Austin District. \$583,511,024 of expenditures were incurred on the Central Texas Turnpike System "2002 Project" (State Highway 45 North, Loop 1, and State Highway 130).

\$2,699,660 of preliminary engineering expenditures were incurred on the State Highway 45 Southeast Project.

*Laredo District*. \$20,080,832 was expended for the purchase of the Camino Columbia Toll Road (includes the closing costs related to the purchase).

No other districts had expenditures related to turnpike projects.

#### **Trans-Texas Corridor**

\$14,507,703 was expended on engineering studies for the I35 and I69 Corridors of the Trans-Texas Corridor Project. This amount includes \$133,816 of expenditures related to Non-Highway Facilities on the Trans-Texas Corridor. These Trans-Texas Corridor Project expenditures are not specific to any TxDOT district.

## Rail Facilities described in Chapter 91

No expenditures were incurred for Rail Facilities as described in Chapter 91.

Non-Highway Facilities on the Trans-Texas Corridor, if subject to Section 227.062(c) No expenditures were incurred for Non-Highway Facilities on the Trans-Texas Corridor subject to Section 227.062(c).

Bonds or Other Public Securities Issued for Transportation Projects

No new bonds or other public securities were issued.

Direction of Money by the Department to a Regional Mobility Authority in the State \$5,081,064 of disbursements were made to, or on behalf of, the Central Texas Regional Mobility Authority, which is located in the Austin District.

# CONCLUSION

This report quantifies agency expenditures. Of course, it has yet to reflect policies in the process of implementation, such as toll roads that will stretch the state's transportation dollar even further, or potential statutory changes such as eliminating the monetary cap on the use of the State Highway Fund for toll equity that will remove barriers to speeding up projects.
