- Unique city sign permit number
- Highway route on which the sign is located (e.g. US 183)
- Latitude/Longitude in decimal degrees (e.g. 30.274652, -97.740379)
- Location must be of structure and not property or address
- Sign owner
- Location (e.g. 200 ft. S of Example St, 123 Main St)
- Face Width & Height (Multiple, different size faces: only include the largest)
- Number of faces
- Poles
- Number of lights on structure



- For Documents:
  - PDF Only
- For Maps:
  - ArcGIS Online Maps/Layers
  - ESRI Format GIS Files or Universal Equivalent (Shapefile, .gdb, .lpx, etc.)
  - PDF
- For Inventory Data:
  - Use the Provided Spreadsheet Only
    - This is to ensure that all data provided is compatible and producible by TxDOT.
  - All fields must be complete, no exceptions
