The 2012 UTP is a comprehensive ten-year plan for the development and construction of State of Texas transportation projects including roadways, aviation, public transportation, waterways and coastal waters, and rail projects and includes specific funding levels for each fiscal year.

**Beginning promptly at 6:00 p.m.**, TxDOT staff will conduct a brief presentation on the purpose and revisions of the 2012 UTP. Additional information will be available for public viewing and TxDOT representatives will be on-hand to discuss the development process and answer questions. This public meeting pertains specifically to the FY 2012 November quarterly STIP revision. TxDOT representatives will be on-hand to answer STIP related questions.
