



**NOTICE  
OPPORTUNITY FOR A PUBLIC HEARING**

**FM 1515  
From Masch Branch Street to Bonnie Brae Street  
Denton County, Texas  
CSJ: 1951-01-011**

The Texas Department of Transportation (TxDOT), in conjunction with Denton County, is proposing the reconstruction and widening of Farm-to-Market Road (FM) 1515 from Masch Branch Street to Bonnie Brae Street within the city of Denton in Denton County, a distance of approximately 2.1 miles. This notice advises the public that TxDOT is affording an opportunity for a public hearing on the proposed project.

The proposed improvements to FM 1515 would consist of the reconstruction and widening to mostly six travel lanes (three in each direction) from Masch Branch Street to Bonnie Brae Street within the city of Denton in Denton County. FM 1515 is an undivided, minor arterial consisting of two 12-foot-wide lanes, 4-foot-wide shoulders and 12-foot-wide turning lanes within an existing right of way (ROW) of approximately 90 feet. The proposed improvements would include two 12-foot wide inside travel lanes and a 14-foot wide outside travel lane to accommodate shared-use of bicycles and vehicles. The proposed number of lanes between Westcourt Road and Western Boulevard along the eastbound would be four (two lanes in each direction), a distance of approximately 1,500 feet, to accommodate entrance to a proposed roundabout at Western Boulevard. The proposed facility would include a raised median, curb and gutter in each direction, and continuous 5-foot-wide sidewalks within a proposed ROW of approximately 140 feet. Additional improvements to FM 1515 would include drainage, cross streets, and driveways improvements. Other improvements include the replacement of the existing bridge structures over Dry Fork Hickory Creek, the Kansas City Southern Railroad and Interstate Highway 35W (IH 35W); and improvements to the southbound IH 35W frontage road.

Approximately 14 acres of ROW and 0.04 acre of easement would be required for the proposed project. Although additional ROW would be required, no residential or non-residential structures are anticipated to be displaced at this time. Information concerning services and benefits available to affected property owners and information about the tentative schedule for ROW acquisition and construction can be obtained from the TxDOT Dallas district office by calling (214) 320-6100.

The proposed project would involve an action in a Federal Emergency Management Agency (FEMA) designated 100-year floodplain. The proposed project would impact approximately 0.09 acre (382 linear feet) of waters of the U.S. at four stream crossings. The placement of temporary or permanent dredge or fill material into potentially jurisdictional waters of the U.S. would be authorized under Nationwide Permit 14 for Linear Transportation Projects without a Pre-Construction Notification. The proposed project would not encroach on any waters or wetlands.

All hearing requests and comments must be received on or before **Thursday, July 9, 2020**. A hearing will be held if ten or more individuals submit timely written requests for a hearing, or if an agency with jurisdiction over the project submits a timely written request for a hearing that is supported by reasons why a hearing will be helpful.
