Project Purpose and Need:

- The I-20 Corridor was constructed in the 1970s and does not accommodate the current/future traffic demands and does not meet TxDOT design standards. The project is needed to improve the following:
 - Mobility: Congestion impacting the movement of people and goods.
 - Connectivity: Inadequate transportation facilities impacting system access.
 - Safety: Traffic incidents impacting vehicular and pedestrian movement.
- The purpose of the proposed study is to improve mobility and connectivity and enhance safety within the corridor.

Meeting Format:

The format of the open-house meeting will be come-and-go with no formal presentation. Project staff will be on-hand to present the alternatives and answer questions.

Highway/ Limits:

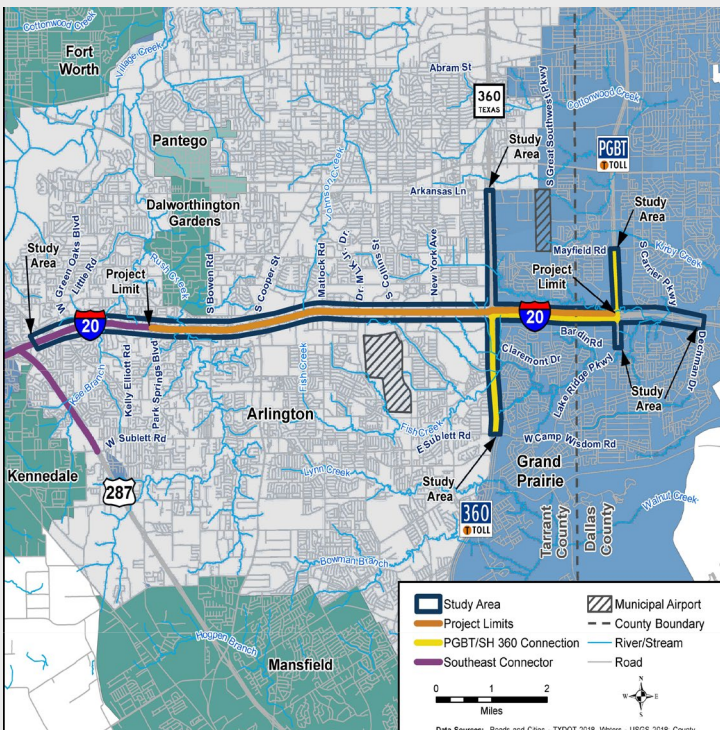
I-20 from US 287 to east of South Carrier Parkway

Project Description:

The I-20 Arlington/Grand Prairie Corridor Study limits are within the cities of Arlington and Grand Prairie in Tarrant and Dallas counties. The study will evaluate connectivity and through traffic movements with the adjacent transportation network: SH 360 from Arkansas Lane to East Sublett Road/West Camp Wisdom Road and PGBT/SH 161 from Mayfield Road to Bardin Road. The study will evaluate potential alternatives to add capacity to the interstate. TxDOT is requesting the public's input on the potential alternatives including the no build option, the addition of general purpose lanes, the addition of general purpose lanes with collector distributors and the addition of general purpose lanes with express lanes.
