



Notice and Opportunity to Comment

FM 1925 (MONTE CRISTO ROAD)

From Wallace Road to FM 2061 (McColl Road)

CSJs: 0921-02-092, 094

HIDALGO County, Texas



The Texas Department of Transportation (TxDOT) and Hidalgo County Precinct 4 are proposing to widen FM 1925 from Wallace Road to FM 2061 (McColl Road); a length of 5.2 miles in Hidalgo County, Texas. This notice is offering an opportunity to comment as part of the environmental review process for this project. If you are a property owner, you are receiving this notice because records indicate that you own property that (1) would be acquired (in part or in whole) for this project or 2) is adjacent to the project. This notice and opportunity to comment is also being provided to affected local governments and public officials.

The purpose of this notice is to advise the property owners on changes that have occurred to the project since May 1, 2019, public meeting. The changes that have been made to the project are as follows:

- It was originally proposed to realign Mon-Mack Road south of FM 1925 to connect to the existing Mon-Mack Road north of FM 1925. This proposal was eliminated due to a utility conflict at the southeast corner of Mon-Mack Road and FM 1925. Due to this design change your property will not be affected and no additional right of way will be required at this intersection. See attached intersection layout.

Although additional right-of-way will be required throughout the roadway project, no residential or non-residential structures are expected to be displaced. Information concerning services and benefits available to affected property owners and information about the tentative schedule for right-of-way acquisition and construction can be obtained from the TxDOT district office by calling Ramon Jimenez at (956) 702-6287.

Any environmental documentation or studies, maps and drawings showing the project location and design, tentative construction schedules, and other information regarding the proposed project are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the phone number provided above. Project materials are also available online at www.txdot.gov (keyword : "FM 1925 from Wallace") or www.hidalgocounty.us/359/Commissioner-Pct-4.

The project materials are written in English. If you need an interpreter or document translator because English is not your primary language or have difficulty communicating effectively in English, one will be provided to you. If you have a disability and need assistance, special arrangements can be made to accommodate most needs. Please be aware that advance notice is required as some services and accommodations may require time for TxDOT to arrange.
