**Opportunity for a Public Hearing**

**MILE 10 NORTH ROAD**

**From Mile 6 West to FM 1015**

**CSJs: 0921-02-360**

**HIDALGO County, Texas**

The Texas Department of Transportation (TxDOT) in cooperation with Hidalgo County Precinct 1, and the City of Weslaco are proposing to widen Mile 10 North Road from Mile 6 W (Westgate Dr.) to FM 1015 in Hidalgo County, Texas. This notice advises the public that TxDOT is affording an opportunity for a public hearing on the proposed project.

The proposed improvements would be to widen Mile 10 North Road from Mile 6 W (Westgate Dr.) to FM 1015; a length of 3 miles, to an urban roadway consisting of four 12-foot-wide travel lanes, a 12-foot-wide continuous left-turn lane, a six-foot-wide sidewalk, and a 12-foot-wide shared-use path within a proposed 90-150-foot-wide ROW. Drainage would be handled by a storm drain system. Turning lanes would be provided at intersections and schools. Two existing outfalls would be widened, cleaned and reshaped to address storm water runoff and existing structures would be removed and replaced.

Although additional right of way would be required, no residential or non-residential structures are anticipated to be displaced at this time. Information concerning services and benefits available to affected property owners and information about the tentative schedule for right-of-way acquisition and construction can be obtained from the Hidalgo County Precinct 1 office at (956) 968-8733.

Any environmental documentation or studies, maps and drawings showing the project location and design, tentative construction schedules, and other information regarding the proposed project are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at Hidalgo County Precinct 1 Offices at 1902 Joe Stephens Ave., Suite #101, Weslaco, TX 78596, (956) 968-8733. If you do not have internet access, you may call Project Manager Jordan Sinclair, P.E. at (956) 585-1901 to ask questions about the project and access project materials at any time during the project development process.

The project materials are written in English. A hearing will be held if ten or more individuals submit timely written requests for a hearing, or if an agency with jurisdiction over the project submits a timely written request for a hearing that is supported by reasons why a hearing will be helpful.
