Virtual Public Meeting with In-Person Option**

The City of McAllen, in cooperation with the Texas Department of Transportation (TxDOT) Pharr District, is proposing to widen Nolana Avenue from FM 2220 (Ware Road) to FM 1926 (23rd Street) in Hidalgo County, Texas. This notice advises the public that TxDOT and the City of McAllen will be conducting an online virtual public meeting on the proposed project with an in-person option. **The virtual meeting will consist of a pre-recorded video presentation and will include both audio and visual components. The presentation will be posted online by Wednesday, December 17, 2025, by 5 p.m. and will remain online for at least 15 days.** To view the virtual public meeting, go to the following web address at the date and time indicated above: www.mcallen.net or www.txdot.gov keyword "Nolana Avenue Widening Project" in the search box. Please note that the presentation will not be available on the website until the date and time listed above. If you do not have internet access, you may call the City of McAllen at (956) 681-1151 between the hours of 8 a.m. and 5 p.m., Monday through Friday, to ask questions and access project materials during the project development process.

Additionally, the City of McAllen, in cooperation with TxDOT Pharr District, is providing an in-person option for individuals who would like to participate in person instead of online. The in-person option will be held in an open house format. In-person attendees will be able to view the same presentation delivered in the online public meeting which will be playing on a screen, review hard copies of project materials, ask questions to City of McAllen and TxDOT staff, and/or consultants, and leave written comments. **The in-person option will be held on Thursday, December 18, 2025, from 5:00 p.m. to 7:00 p.m. at McAllen Public Library, Meeting Rooms A & B, 4001 N 23rd St, McAllen, TX 78504.**

The improvements proposed along Nolana Avenue, would be to widen the existing roadway 14.5 feet to each side for an ultimate 91-foot-wide face to face urban facility consisting of six-12-foot-wide travel lanes, a 14-foot-wide concrete raised median, a six-foot-wide sidewalk on the south side and a 10-foot-wide shared-use path on the north side within an existing 120-foot-wide right of way (ROW). The project length is one mile. No new ROW or easements are required. The project is within the City of McAllen, in Hidalgo County.

Any environmental documentation or studies, any maps and drawings showing the project location and design, tentative construction schedules, and other information regarding the proposed project are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the City of McAllen, 1300 Houston Avenue, McAllen, TX 78501, (956) 681-1151. Project materials are also available online at www.mcallen.net or www.txdot.gov keyword "Nolana Avenue Widening Project" in the search box. These materials will also be available in hard copy form for review at the in-person option.



The virtual public meeting and in-person option will be conducted in English and Spanish. If you need an interpreter or document translator because English is not your primary language or have difficulty communicating effectively in English, one will be provided to you. If you have a disability and need assistance, special arrangements can be made to accommodate most needs. Please be aware that advance notice is required as some services and accommodation may require time for the City of McAllen to arrange.
