This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a final environmental impact statement (FEIS) for the proposed State Highway 68 (SH 68) and is available for review. The FEIS identifies the selected alternative, and signifies the completion of the environmental review process which would construct a new location 4-lane rural highway facility with future mainlanes and overpasses for approximately 22 miles from I-2/US 83 to I-69C/US 281 in Hidalgo County, Texas.

The FEIS is on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at Texas Department of Transportation (TxDOT) Pharr District Office located at 600 W. Interstate 2 (I-2) Pharr, Texas 78577. It is also available online at www.txdot.gov, keyword "SH 68".

A record of decision and an associated Notice of Availability will be issued 30 days after this notice signifying the completion of the environmental review process.
