From I-2/US 83 to I-69C/US 281

This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a Record of Decision (ROD) for the proposed State Highway 68 (SH 68) and is available for review. The ROD identifies the selected alternative, and signifies the completion of the environmental review process which would construct a new location 4-lane rural highway facility with future mainlanes and overpasses for approximately 22 miles from I-2/US 83 to I-69C/US 281 in Hidalgo County, Texas.

The ROD is on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at Texas Department of Transportation (TxDOT) Pharr District Office located at 600 W. Interstate 2 (I-2) Pharr, Texas 78577. It is also available online at www.txdot.gov, keyword "SH 68".
