### LEGAL NOTICE OF PUBLIC MEETING

---

The Texas Department of Transportation (TxDOT) will conduct a public meeting on Thursday, June 27, 2019, to present its proposed revisions to the 2019-2022 Rural Transportation Improvement Program (TIP). The meeting will be from 4 - 6 p.m. at TxDOT Tyler District Office located at 2709 West Front Street, Tyler, Texas 75702. Representatives will be available to answer individual questions.

The Rural TIP is a listing of federally funded projects that will be implemented and/or constructed in the next four years. Transportation improvements throughout the District's eight county area – consisting of Anderson, Cherokee, Gregg, Henderson, Rusk, Smith, Van Zandt and Wood counties – are part of this plan.

This meeting will discuss the addition of the FM 2493 project within Cherokee County (CSJs 0191-04-008 and 0191-02-066). The project consists of widening the roadway from two to four lanes with a flush median and constructing a grade-separated interchange at its intersection with US 69. The project requires additional right-of-way and acquisitions are expected to commence this year. Construction is tentatively scheduled for 2023, pending available funding. Maps and other project details will be available for review at this meeting.

All interested parties are invited to attend in order to gather information and provide feedback. Persons with special communication or accommodation needs, including language interpreters, should contact TxDOT at (903) 510-9100 at least two working days prior to the meeting. Every reasonable effort will be made to accommodate those needs.

Written comments, related to the Rural TIP, may be submitted at the meeting or mailed to the Texas Department of Transportation Advanced Project Development Office, 2709 West Front Street, Tyler, Texas, 75702. Comments may also be emailed to [william.tobin@txdot.gov](mailto:william.tobin@txdot.gov). All comments must be received by Tuesday, July 9, 2019, to be a part of the official record.
