Virtual Public Meeting with In-Person Option

TxDOT is conducting a feasibility study to explore a potential relief route around the City of Sealy in Austin County, Texas. This notice advises the public that TxDOT will be conducting an online virtual public meeting on the proposed project with an in-person option. **The virtual meeting will consist of a pre-recorded video presentation and will include both audio and visual components. The presentation will be posted online by Thursday, Jan. 22, 2026, at 4:30 p.m., and will remain online until Friday, Feb. 6, 2026.** To view the virtual public meeting, go to the following web address at the date and time indicated above: www.txdot.gov, keyword search “Sealy Relief Route.” If you do not have internet access, you may call 361-293-4460 between the hours of 8 a.m. and 5 p.m., Monday through Friday, to ask questions and access project materials during the project development process.

Additionally, TxDOT is providing an in-person option for individuals who would like to participate in person instead of online. The in-person option will be held in an “open house format” where attendees may come and go at their convenience. In-person attendees will be able to view the same presentation delivered in the online public meeting which will be playing on a screen, review hard copies of project materials, ask questions of TxDOT staff and/or consultants, and leave written comments. **The in-person option will be held on Thursday, Jan. 22, 2026, from 4:30 to 6:30 p.m. at Sealy Columbus Club, 1310 Hwy 90 West, Sealy, TX 77474.**

The virtual public meeting and in-person option will be conducted in English. If you need an interpreter or document translator because English is not your primary language or you have difficulty communicating effectively in English, one will be provided to you. If you have a disability and need assistance, special arrangements can be made to accommodate most needs. If you need interpretation or translation services or you are a person with a disability who requires an accommodation to attend and participate in the virtual public meeting or in-person option, please contact Lucean Kuykendall, TxDOT Yoakum District Public Information Officer, at 361-293-4436 no later than 4 p.m. CT, Friday, Jan. 16, 2026. Please be aware that advance notice is required as some services and accommodations may require time for the Texas Department of Transportation to arrange.
